## **Books**

- 1. Christopher D. DeSante Boiling Point: How Global Warming Fuels Polarization in America. Under Review for an advanced contract with Cambridge University Press, August 2024. Summary: Using 130 years of data from the National Oceanic and Atmospheric Administration (NOAA), I have tracked and computed the change in the mean monthly temperature of Congressional district polygons for U.S. Congressional Districts going back over forty years and five different redistricting cycles. Comparing the average change in temperature for each polygon using a robust variety of methods, I find compelling evidence that 1) citizens who live in districts that are warming more have a greater concern for climate change; 2) that members of Congress who represent those districts appear to be more pro-environment in their roll call votes, and 3) that districts represented by Democrats have experienced greater relative shifts in temperature as we measure it. I take this as strong evidence that Americans are paying attention to their local climate, that legislators are responding to district-level climate change, and that Democratic districts are warming more quickly due to their concentration inside urban areas.
- 2. Christopher D. DeSante Learning Statistics: A Meta-Pedagogical Approach. Under Review at Pearson and Sage, August 2024.

Summary: An introduction to statistics textbook written with specific attention paid to the metacognition of students inside the college classroom. Using data and examples from not just political science and learning science research, the book includes data related to the mental health

outcomes of today's high school and college students with particular attention to "math anxiety," clinical depression and anxiety, and attitudes about education. The book covers an introduction to data science in R from basic summary statistics to multivariate regression and limited dependent variables estimated via maximum likelihood. The book is currently being printed at IU's printshop for use in my two semester undergraduate statistics sequence (Fall 2024, Spring 2025) while it is under review for publication.
